### Why is Mellow collecting this data?

The Dextra service helps freelancers find job opportunities by using AI-assisted tool to conduct and optimize cold outreach campaigns..

To provide this service, Mellow collects and processes the following data:

- Full name,
- Email address,
- Email content (including messages sent as part of campaign),
- Metadata related to emails (timestamps, delivery status, etc.),
- Al-generated recommendations, message suggestions based on campaign data,
- Technical data (IP address, browser information) for service delivery and security.

Payment data: payment card details and transaction data are processed by our payment service providers (PSP). Mellow does not store or access full payment card numbers.

### How do we use users' information?

All information collected is used to:

- Core service delivery and functionality,
- AI-powered features and automated processing,
- Payment processing,
- Platform security and fraud prevention,
- Service improvement and optimization,
- User support and communication,
- Send marketing communications with users' separate consent.

Mellow does not use this information for unrelated marketing or profiling beyond service improvement.

# What is our legal basis for this processing?

- Consent under Article 6(1)(a) of the GDPR where users choose to receive marketing communications.

## Will you data be shared?

We may share your data with:

- Trusted service providers who support platform operation. Some of these providers may be located outside the EEA. Where applicable, we use appropriate safeguards such as Standard Contractual Clauses or adequacy decisions,
- Other Mellow entities for service delivery, technical support, and platform improvement,
- Law enforcement or regulatory authorities when legally required or to protect our legitimate interest.

We do not sell your personal data or share it for advertising or unrelated commercial purposes.

## How long will we retain non-user information?

Mellow retains personal data as follows:

- Account information: While your account remains active and for up to 2 years after account closure to comply with legal obligations, resolve disputes, and prevent fraud,
- Campaign and communication data (including email messages, metadata and analytics) is retained for up to twelve (12) months from the data of interaction, unless deleted earlier by you.
- Technical and security data: Up to 6 months for security and fraud prevention purposes.

Other data may be retained longer where required by law, for dispute resolution, regulatory investigations, or legitimate audit purposes. You may request earlier deletion of your data, subject to our legal and legitimate business obligations.
